1 INTRODUCTION

1.1 Scope and layout of document

3 PROJECT SCHEDULE

This version of the document does not include a detailed project schedule.

Such a schedule will be provided after consultation with the CUSTOMER, and specifically after more detail about the selected system and implementation options is available.

The delivery times (after receipt of order), are shown in the COMMERCIAL OFFER.

It is estimated that the complete project can be implemented during a 12 month period, excluding the satellite interception capability. This can take longer, depending on the actual delivery time of the satellite antennas and the completion of site preparation and civil works.

High level implementation options include the following:

Preliminary work

In all cases, the options below must be preceded by a period of approximately 3 months, during which preparatory system engineering and project management work will be done, including the following:

- Detailed system engineering work-sessions and specifications
- Detailed project management planning
- Site surveys and measurements (specifically in the case of the satellite interception sites)
- Central site and selected PSTN/PLMN remote sites

This work includes the following:

- Establishing all links between the remote sites and the central site
- The central site infrastructure will be implemented complete
- o Interception at the selected remote sites will be implemented complete
- Zebra Capture Units related to the selected remote sites will be implemented. This
 could be done to sub-capacity, with the full capacity installations being done at a
 later phase.
- o Zebra Data Centres will be implemented.
- Training will be provided.
- Grow implemented MMS system by implementing satellite interception sites
- Capacity upgrades.
